Definition and Purpose

Throughout history man has had the need to memorialize the dead. Generally, this need has been satisfied by placing some form of identification at the grave of the deceased. This identification generally serves to commemorate and mark the burial place of a loved one.

At Ivy Hill this memorialization generally consists of one of three different forms of marking a grave. They are monuments, markers and memorials.

Monuments take the form of above grade level grave identification made of stone or stone and bronze, that by their size covers more area than that allowed for one interment space, on which names, carving or epitaph can be placed.

Markers by definition here at Ivy Hill are any above grade level grave identification made of stone or stone and bronze that by their size cover not more area than that allowed for one interment space.

Memorials here mean grave identification made of stone, bronze or a combination of both that are set in such a manner that they are flush with the grade of the ground into which they are installed.

In recognition of the desire to memorialize an individual family member's grave, Ivy Hill Cemetery incorporated various styles of memorialization in its cemetery. Thus, individual families have the opportunity to select memorials in keeping with their particular tastes and in accordance with the Rules and Regulations.

Ivy Hill Cemetery is dedicated to long range preservation of the Cemetery grounds as an attractive, reverent setting for the sacred burial of the dead. In keeping with this responsibility and to maintain the aesthetic beauty, as well as keeping the overall maintenance requirements of its cemetery at manageable levels, certain Sections and Lots in the Cemetery are restricted as to the use of monuments, markers or memorials. Information as to a specific lot must be obtained at the office, and all persons concerned should contact the Management before placing an order for such material. Ivy Hill has found it necessary to implement certain rules, regulations and fees with regard to memorialization in its cemetery.

A fee equal to the fee for the Cemetery's placement of a foundation or equal to the cemeteries fee for installation of a bronze memorial is required as a contribution to the Care/Maintenance Endowment Funds established by the Cemetery for preservation of the Cemetery grounds as stated above. A portion or contribution from the sale of all Interment rights, interment fees themselves and a contribution, from any and all sources, for the placement within the Cemetery of any monuments, markers, or memorials.

The required contribution to these Care/Maintenance Endowment Funds from any source does not convey any specific care of any interment, foundation, installation, monument, marker, or memorial. The exception to this statement of fact is payment of the required fee for the specified Bronze Care Funds. Here the care is tied directly to the individual Bronze memorial not to the general maintenance of the Cemetery as a whole.

The purpose of this document, along with the General Rules and Regulations for the Cemetery, is to clearly and concisely convey <u>ALL</u> the rules, regulations, requirements, fees/contributions and specifications, especially for **memorialization** purchased and installed by dealers other than the Cemetery who may not be as familiar with all of the aforesaid items.

A: Authorization.

1. All forms of memorialization dealers are eligible to become an Authorized Dealer

by:

- a. Signing an Authorized Dealer Agreement.
- b. Authorized dealers are required to provide Ivy Hill Cemetery with a Liability Insurance Certificate. The certificate must show evidence of \$1,000,000 comprehensive general liability, \$1,000,000 vehicular liability and \$100,000/\$300,000 workers' compensation coverage. Authorized dealers should contact the Cemetery office to determine minimum amounts of insurance required by the Cemetery. This certificate must be updated yearly by the dealer's insurer when policies are renewed.
 - c. Continuing to adhere to the terms of the Agreement and continuing to keep their insurance in force.

B: Application.

- 1. The forms such as the <u>Application to Install, Application to Inscribe, Foundation Installation Intentions</u> and <u>Specifications</u> are available to all authorized dealers upon request.
- 2. Before a monument, marker or memorial may be placed in the Cemetery, a completed <u>Application to Install</u> form (Dealer Form 1) must be presented to the Cemetery for approval together with payment of all fee requirements. (Dealer Form 6)
- 3. Before a monument, marker or memorial has any inscription changed or added an authorized dealer must present to the Cemetery for approval a completed Application to Inscribe. (Dealer Form 5) together with payment of all fee requirements. (Dealer Form 6)
 - 4. Approval of the application requires that:
 - a. The Application to Install or Inscribe,
 - b. The Foundation Installation Intentions.
- c. Specification Form including the sketch be completed and all forms be signed by the appropriate Interment Right Owner, heirs, or agent and where indicated by the memorial dealer.

5. Acceptance of payment indicates approval of the application; however, approval of the monument, marker or memorial is subject to inspection upon delivery and installation in the Cemetery. Should a Application not be approved, it shall be returned to the dealer with a form indicating the reason or reasons for the non-acceptance. (Dealer Form 2)

C. Rules and Regulations, Permit Requirements.

- 1. The Rules and Regulation of the Cemetery contain additional items that are not repeated in this document but are nevertheless just as important and binding as anything contained herein.
- 2. Authorized Dealers should pay particular attention to Section 3, WORK PERMIT and Section 4, IDENTIFICATION.

3. Permit Requirements

- a. Commercial Vendors (Authorized Dealers) upon entering the Cemetery are required to come into the office to sign for and pick up a Commercial Work Permit before proceeding with their task.
- b. The reason for the permit must be provided. Installations and Inscriptions require an appointment made at least 24 hours in advance.
- c. The Permit must be displayed in the window of the Vehicle at all times and cemetery personal may check for same and ask any Commercial Vendor to go to the office and obtain a Permit or to leave the cemetery. Failure to comply will constitute trespass and may be dealt with accordingly.
- d. The permit must be returned and the vendor signed out by 2:00 PM unless prior arrangements have been made.

D. Foundation Installation.

- _____1. Foundations may be installed by an authorized dealer or the dealer may choose to have the Cemetery install the foundation. Foundations may be installed throughout the year, weather permitting.
- 2. Authorized dealers installing the foundation must have the fee for the layoff and recording of the installation accompany the application as well as the Care/Maintenance Endowment Fund contribution.

- 3. Should the dealer wish to have the Cemetery install the foundation, payment for the foundation must accompany the application as well as the Care/Maintenance Endowment Fund contribution
- 4. The improper installation of foundations can be grounds for non-acceptance of an installed memorial and loss of Authorized status.

E. Installation.

- 1. The authorized dealer is responsible for installation of the monument in accordance with the requirements and conditions set forth in the <u>Application to install</u> (Dealer Form 1) and shall use such techniques and procedures as will insure maximum permanence of the installation.
- 2. Installation or inscriptions of monument, markers or memorials is limited to the regular week day working hours of the Cemetery office: Monday through Friday, 9:00 A.M. to 2:00 P.M. No installations will be authorized on Saturday or Sunday. The Cemetery office must be notified 24 hours in advance of all authorized dealer memorial installations.
- 3. Authorized dealers or their agents involved in placement of lettering on monuments, markers or memorials must submit the Application form before lettering work is started.
- 4. The Cemetery has adopted certain regulations to preserve uniform beauty and equality of all bronze memorials. All bronze memorials are subject to these as set forth in the Rules and Regulations (Subpart C. Bronze) and further the bronze must meet the minimum specifications as contained therein.
- 5. The Cemetery shall not permit the installation of any structure that would interfere with the general good effect of the grounds or obstruct the view or cause annoyance to adjoining Owners, or to use tablets or ledgers which cover a major portion if not all of the interment space so as to prevent maintenance equipment from having access to the lot itself or to adjacent lots.
- 6. Individual markers shall not exceed 3' 2" feet in height, 2 feet 6 inches in length or 1 foot 6 inches in width. These size limitations will decrease in specific areas and lots.
- 7. Monuments without the express permission of the Cemetery, shall not exceed 4 feet in height, 4 feet 6 inches in length or 1 foot 6 inches in width. The Cemetery will require a reduction of 6 inches in the height and length of monuments where placement is limited or intended to be for 2 sites. These size limitations will decrease in specific areas and lots.
- 8. No marker or monument shall be installed until the space to be used for said marker or monument is paid for in full.

F. Financial.

- 1. A monument, marker or memorial may not be placed on any lot until the lot involved has been paid for in full. Specific information on the status of each lot will be provided at the time the application is submitted; and if there is any limitation regarding the acceptance of the application or the installation of the said item, the family will be contacted by the Cemetery.
- 2. All applicable fees for permits, layoff, foundation, installation or the contribution to the specific Bronze Care Funds and or the Care/Maintenance Endowment Fund contribution must be made prior to any work being commenced in the Cemetery.
- 3. Authorized dealers are subject to the rules and regulations of the Cemetery both in terms of work time and operational procedures. Damage to Cemetery grounds or other damage caused by these dealers will be repaired at the expense of the dealer. If it is necessary for equipment to leave the road surface, permission MUST be obtained from the Cemetery prior to doing so and precautions MUST be taken to protect the Cemetery grounds.
- 4. Once a monument, marker or memorial is installed in the Cemetery, it may not be removed without permission of the Cemetery or a court order.

G. <u>Liability.</u>

- 1. Monuments and markers are the personal property of the individuals who purchase them. Cemetery insurance does not cover privately owned monuments or markers, and damage to same as the result of vandalism and acts of God are the responsibility of the individual owner.
- 2. Memorials sold by the cemetery or those placed by authorized dealers that have care provisions have limited coverage for damage and vase theft.
- 3. Where minor damage from unknown sources takes place, the cemetery may, where possible, make or arrange some suitable repairs, both as a courtesy to the lot holder and in the interest of maintaining a more attractive appearance.
- 4. In the case of serious vandalism involving damage to monuments or markers, the cemetery will notify the affected lot holders, if addresses are available, and, where possible, will take such temporary measures as necessary to lessen the damage. If lot holders subsequently fail to make permanent repairs, the Cemetery will dispose of the monuments and markers or make repairs and charge the lot owner for same.
- 5. The Cemetery assumes no liability for dealers or their employees or agents while on Cemetery property.

AUTHORIZED DEALER AGREEMENT

The undersigned dealer warrants that the person(s) making applications pursuant to this agreement have authorized this dealer to construct, install or inscribe a monument, marker or memorial on the described lot and that the Specifications Form (Dealer Form 4) contains the specifications and detailed sketch of the memorial.

The dealer agrees to comply with the Requirements/Regulations/Specifications for the Sale and Installation of Markers, Monuments and Memorials by Authorized Dealers and the Fees, Rules and Regulations of the Cemetery now in force or hereafter adopted including but not limited to the following:

- 1. The Dealer agrees to furnish Ivy Hill Cemetery a blueprint or sketch (to scale) of the proposed monument, marker or memorial specifying size, location, inscription, material, grade or quality of said item and name of person or company furnishing said item.
- 2. The Dealer agrees to furnish the Cemetery with a Certificate of Insurance naming lvy Hill Cemetery Company of Alexandria, as an additional insured. The Certificate of Insurance shall be for the amounts deemed appropriate by the Cemetery and specified in the REQUIREMENTS/REGULATIONS/SPECIFICATIONS publication for Authorized Dealers.
- 3. The Cemetery shall have the authority to reject any plan or design for any monument, marker or memorial which, because of size, design, inspection, kind or quality of said item is unsuitable in the opinion of the Cemetery.
- 4. The Cemetery reserves the right to stop all work of any nature, whenever, in its opinion, proper preparations therefor have not been made; or when tools or machinery are insufficient or defective; or when work is being executed in such a manner as to threaten life or property; or when the item being installed is not as approved by the Cemetery; or when any reasonable request of the Cemetery is disregarded; or when work is not being executed according to specifications; or when any person employed on the work violates any rule of the Cemetery.
- 5. The Cemetery further reserves the right not only to stop specific jobs but, if necessary, to terminate this agreement for violation of the terms of this agreement. A Dealer that is not authorized may not enter the Cemetery for any commercial purposes.
- 6. Workmen employed in placing and installing monuments, markers or memorials and any other structures, or bringing in material, shall, as to the Ivy Hill Cemetery, operate

as independent contractors, but must do so under permission from the Cemetery and must be under the general supervision of the Management of the Cemetery.

- 7. Persons engaged in placing and installing monuments, markers or memorials and any other structures, are prohibited from attaching ropes to existing monuments, trees, and shrubs, or from scattering their material over adjoining lots, or from blocking roads, paths or walkways, or from leaving their material on the grounds longer than is absolutely necessary. They must do as little injury to the grass, trees and shrubs as possible and must remove all debris and restore the ground and sod to its original condition. Work must proceed promptly until completion.
- 8. Damage done to lots, walks, drives, trees, shrubs, or other property, by dealers or contractors, or their agents, shall be repaired, at the discretion of the Cemetery, by the Dealer or by the Cemetery and the cost of such repair if done by the Cemetery shall be charged to the dealer or contractor, or to his principal.
- 9. No material, machinery, or other items used in the construction of monuments, markers or memorials may be brought into the Cemetery until required for immediate use; under no circumstances shall material, machinery or other items be brought in when a funeral is in process or on Saturday and Sunday; no work shall be done during said times nor shall such material be placed on lots adjoining the one on which such an item is to be placed without permission from the Management of the Cemetery.
- 10. The completed work is subject to the approval of Ivy Hill Cemetery and, if unsatisfactory, it may be removed by the Cemetery.
- 11. Should any monument, marker or memorial become unsightly, dilapidated or a danger to visitors, the Cemetery shall have the right either to correct the condition or to remove same at the expense of the lot owner.
- 12. No monument, marker or memorial shall be removed from the Cemetery except by Ivy Hill Cemetery, unless written order of the lot owner be presented at the office of the Cemetery and permission granted by the management of Ivy Hill Cemetery.
- 13. The Cemetery reserves, and shall have, the right to correct any error that may be made by its employees or by any other person with respect to locating, placing or constructing a monument or marker within the Cemetery.
